Godparent Information

The Catholic Church requires the following of Godparents: (canon 874.1)

- The godparents are to be chosen by the parents or guardians.
- They are to be at least sixteen years of age.
- They must be Catholics who have already been Baptized, Confirmed and have received the Holy Eucharist.
- They should be leading a life in harmony with the faith, practicing Catholics (attending Mass), if married, in a valid Catholic Marriage, etc.
- They may not be the father or mother of the one to be baptized.
- You may choose one or two godparents. If you choose two, one must be male and the other female.
- The godparents must have the qualifications for and intention of carrying out this duty.
- **Non-Catholic Witness (Can.874.2) A <u>baptized</u> person belonging to a non-Catholic ecclesial (church) community may be admitted as a witness to baptism but only along with a Catholic Godparent. This person is not formally called a Godparent but will be referred to as a Christian Witness.

The Catholic Church requires that a candidate for Baptism (that is, for membership in the Church) be given a godparent(s) who is(are) willing and able to help the child develop and grow in the Catholic faith. According to Canon Law, those designated as godparents must have received the three sacraments of initiation (Baptism, Confirmation, and Eucharist) and must also "...be members of the Catholic Church and be canonically free to carry out this office". Some impediments to carrying out such a responsibility include such things as living in a marriage which is not recognized as valid in the eyes of the Catholic Church, being in an irregular living arrangement, not attending Sunday Mass, or being a part of such situations, which could be considered scandalous. Furthermore, one must be at least 16 years old to serve as a sponsor. In the case where there are two sponsors, one must be male and the other female. A baptized non-Catholic may not be a sponsor but may act as a witness. Non-baptized persons may not serve in the role of godparents or witness in the Baptism of a person in the Catholic faith.
